<u>Secretary's Report</u>: Minutes of the February 16, 2023, meeting was circulated by email. Bob motioned to accept the Minutes; Dale seconded; Minutes accepted.

Treasurer's Report: Jim read the Treasurer's Report (also circulated by email). At the end of March there was \$13599.05 in checking; \$2177.16 in savings; \$15,776.21 in total. Ozarkian and Canadian "Periods" John A. Catalani

The Geologic Time Scale that we use today has been refined over the years into internally consistent divisions of deep time. Along the way, however, there have been diversions in the placement and naming of Time Scale units. Two of these units involve the Geologic Period that I am most familiar with--the Ordovician.

Recall that the Ordovician Period (System) was a compromise by British stratigraphers to solve the Cambrian-Silurian boundary dispute. Charles Lapworth in 1879 erected the Ordovician System to include rocks claimed by both Adam Sedgwick for his Cambrian System and Roderick Murchison for his Silurian System thus ending a decades old "debate". It was not until 1903 that the term Ordovician was officially adopted by the United Staes Geological Survey, not until 1906 that British and Irish geologists accepted the term Ordovician, and not until 1960 that the International Geological Congress officially accepted the Ordovician as part of the Geologic Time Scale.

Geologic Systems are not static entities. They are in a constant state of flux. For example, a major direction recently in Ordovician and other Systems research has been to establish Global Stages for each System. This Global effort resulted from intense field work culminating in the establishment of Global Sages allowing for meaningful comparisons of Ordovician sections and faunas world-wide. In establishing these Global Stages, new techniques were employed to fine-tune resolution of the units and establish increasingly more accurate ages.

One technique that has both simplified and complicated Ordovician stratigraphy is the use of K-bentonite beds. K-bentonites are altered volcanic ash layers, often from a single volcanic eruption, that identify a virtual instant in time (isochronous units). Since K-bentonites can be correlated over large distances using elemental composition, they have the potential of allowing us to place variously named stratigraphic units in a time ordered sequence very accurately. On the other hand, such specific time designations can cause problems for certain previously assigned rock units. For example, in Illinois the Deicke K-bentonite occurs at the top of the Platteville Formation—a useful marker bed. In Minnesota, however, the Deicke is positioned within the Carimona Member, the uppermost member of their Platteville Formation. This presented a bit of a stratigraphic dilemma. The state surveys logically reassigned the Carimona above the Deicke to a Member of the overlying Decorah Formation. These isochronous markers can also be used to determine ages of the ash flows by two main radiometric methods: 40 Ar/39 Ar on biotite crystals and 238 U/206 Pb on zircon crystals. The application of these isotopes has decreased the uncertainty in the ages and thus improved the resolution of the stratigraphic units.

Back to the Ozarkian and Canadian. My first exposure to the so-called "Canadian System" occurred while visiting Rousseau Flower in New Mexico. He was the foremost authority on nautiloids, particularly those from the Ordovician, in the world. (Rousseau has since passed away and his passing was an enormous loss both for the science of paleontology and for those of us who reveled in such legendary and colorful paleontologists.) During my visits with him our talks often ranged beyond my Platteville specimens and included the evolution of nautiloids in general. In the course of these talks, he discussed those nautiloids that came before mine calling this time the Canadian System rather than the Lower Ordovician. Rousseau, of course, based his Canadian System on a comparison between nautiloid faunas of the "Canadian" and the "Ordovician". Nautiloids of the orders Ellesmerocerida and Tarphycerida dominate Canadian faunas. These orders are, however, relatively minor in the post-Canadian Ordovician. A subsequent diversification of the nautiloids produced faunas dominated by six or seven (depending on whose classification one uses) additional orders that were either minor or nonexistent in the Canadian.

Flower (1964, p. 150) stated that "the Canadian-Ordovician boundary appears as a horizon at which profound changes took place in the cephalopods".



E. O. Ulrich's lower Paleozoic Systems.

Before Rousseau, E. O. Ulrich, an early stratigrapher who believed that fossils were inadequate for defining stratigraphic boundaries employing instead erosional surfaces to define said boundaries, proposed two new Systems that were to be placed between the Cambrian and the Ordovician. He named these Systems Ozarkian and Canadian. In my opinion, Ulrich made two mental errors in his attempt to revise the Geologic Column: 1) proposing not one but two additional Systems so soon after the Ordovician System was adopted and 2) employing a radical new method (akin to today's sequence stratigraphy) to define these systems, a method that the geologists of the time were unable or unwilling to accept. Additionally, several of his boundary correlations were inaccurate to the point that some of his "distinct" boundaries were eventually proved to be equivalent. Flower (1964, p. 17) commented on these Systems and concluded that "there is a tendency to forget the Ozarkian completely and to treat the

Canadian as merely the basal part of the Ordovician, a usage which the writer finds impossible in relation to the cephalopods". Unfortunately, by the time Rousseau came along with his Canadian System, one based on a careful evaluation of the cephalopod faunas, the established time scale proved impregnable. Both Ulrich's Ozarkian and Canadian Systems and Flower's Canadian System are now included in the Early Ordovician Epoch.

(I actually do use one of these terms when presenting programs on cephalopods. When referring to faunas before the Platteville (Smithville, Gasconade, etc.), I often combine these faunas under the umbrella of Ozarkian faunas.)
