## **Directions to the Orr Building Illinois State Fairgrounds**

From I-55 North or South, take Exit 100 B and merge with E. Sangamon Ave and proceed west. Stay on E. Sangamon Ave west for ~2.5 miles and turn right on N. 8<sup>th</sup> St for ~.4 miles and turn left on 4 H Rd (at the turn, the Swine Building will be on your right and after the turn a short distance the Orion Samuelson

Building will be on your right). Continue ahead ~.2 mi to the Orr Building on your right (66 4 H Rd; see map page 3 this Digest). **Caution:** Access to the Orr Building from 5<sup>th</sup> St is often blocked by a gate.

## **\*\*\*Dates for MAPS EXPO to change starting in 2025\*\*\***

Dear MAPS Members and Show Vendors,

After much discussion and checking on available dates, **the MAPS Board has decided to move the dates of the 2025 and 2026 EXPO shows to April**. For many years, the show was always held in April but was moved to October when we moved the show to Springfield, Illinois. This was done because at that time only the October dates were open.

Like many of you, we are also concerned about the decrease in attendance. We feel that there are probably many factors that impact the turnout. One of these factors is probably the number of sales that are now carried out via the Internet, for which we have no control. Another factor is that the local club in Springfield has their show just two weeks before our show. We feel that this is affecting local attendance at our show. In addition, there are many other activities taking place at this time of the year. Thus, we feel that by moving EXPO back to April we will hopefully avoid some of these conflicts.

We have talked to Dan Cooper on this, as far as the Motel Show, and he is in support of this change. In addition, Dan is also working on fossil kits for the kids, which we hope will draw in kids and their parents.

**The dates for the 2025 EXPO will be April 25-27, and the dates for the 2026 EXPO will be April 24-26.**

I would also ask that everyone help promote the show by whatever methods you can think of. We will be using social media extensively as we get closer to our October show, so please repost flyers when you see them on your pages.

We are open to any constructive ideas you may have on getting the word out on our show.

**LOCATION:** EXPO will be held at the Orr Building located on the Illinois State Fairgrounds, 801 E Sangamon Ave., Springfield, Illinois.

**EXPO HOURS:** **Friday, October 18: 9:00 a.m. - 5:00 p.m.**  
**Saturday, October 19: 8:00 a.m. - 5:00 p.m.**  
**Sunday, October 20: 8:00 a.m. - 3:00 p.m.**

**SET-UP:** (See Note to Dealers below) Normal set-up will take place on Friday, **October 18**, at 7:30 a.m. However, for those that want to set up their tables on Thursday, October 17, MAPS has arranged for the building to be opened with set-up from **1:00 p.m. to 6:00 p.m.** on Thursday. **Buying, selling, or trading will NOT be allowed on Thursday and will be enforced. NOTE: There will be no security Thursday night.**

**NOTE TO DEALERS:** **All-hands-on-deck** for arranging tables in show format Thursday at **1:00 p.m.** **At this venue, we are responsible to set up tables--YOUR TABLES.**

**Additionally:** from comments on last year's show, all dealers may want to consider using skirting on their tables to enhance material presentation.

**PARKING:** Parking at the Orr Building is free.

**TRANSPORTATION:** The Orr Building (Illinois State Fairgrounds) is accessible via I-55 to E. Sangamon Ave. (Exit 100) west to the Fairgrounds. Business I-55 (Veterans Parkway) can also be used. See location maps page 3 this issue and Directions to Orr Building p. 2 this issue. The Abraham Lincoln Capital Airport is located just west of the Fairgrounds.

**HOTELS/MOTELS:** Although the "Hotel Show" will be located at the Northfield Inn (217-523-7900) (see p. 5 for more information), there is a wide variety of hotels/motels of varying price ranges just off I-55 in Springfield. If you plan to stay in a motel, we urge you to make your reservations early.

**ADMISSION:** Admission is free for the 2023 EXPO Show. However, free-will donations will be appreciated.

**SALES TAX:** The sales tax rate for the Fairgrounds is 7.25%. For those without an Illinois tax number, there is a simple form available. The sales tax rate for the Hotel Show and the rest of Springfield is 9.75%.

**EXPO THEME:** **Carboniferous Period** will be this year's theme. Friday night's Keynote Speaker will be Joe Devera, Illinois State Geological Survey, and his program, **Late Mississippian Vertebrate Fossils from the Buncombe Red Bed, Southern Illinois**, will be given at the Northfield Inn following the presentation of the Don Good and Sharon Sonnleitner Awards and is open to the public. Updates on the website.

**CALL FOR PROGRAM SPEAKERS:** Each day of EXPO, a number of programs/lectures/workshops are given by members and interested individuals on-site at the Orr Building. These programs average 40-60 minutes in length, are usually given in PowerPoint format, and deal with various topics often, but not always, in line with the theme for that year. ## EXPO XLV POLICIES--GENERAL

- Everyone is expected to stay through 5:00 Saturday and all are encouraged to stay through Sunday.
- Please note your plans for leaving on the reservation form.
- Aisles must be kept clear at all times.
- No pets are allowed except for certified service animals.
- **The Board insists that all materials be fossil or fossil-related.**
- **Mountings, gemstones, minerals, human remains, artifacts, or relics, etc., are NOT PERMITTED!!!!**
- **The Board expects all fossils sold to have been LEGALLY collected**
- **It is assumed that all fossil material be authentic and that any alteration/reconstruction be divulged.**
- **No smoking, vaping, alcohol, firearms, or disruptive behavior will be permitted on site.**

## EXPO XLV POLICIES--TABLE COSTS AND ASSIGNMENTS

- Cost of tables remains \$30.00 each for the first three SIX FOOT tables. Tables 4-8 will cost \$40.00 each. Additional tables by availability.
- MAPS will be charged for clean-up. Therefore, dealers are requested to remove table coverings and dispose of refuse. Extra clean-up costs can be charged to dealers.
- **Admission to EXPO is free. Tax deductible donations are accepted and appreciated.**

- Due to delays in the local mail system, **it would be prudent to send in table registration/fees early.**
- The floor plan will be first laid out on **September 1**, with all received **PAID** requests being assigned tables. Thereafter, tables will be assigned on a first come/first served basis. This is necessary to ensure fairness to all registrants and to determine remaining number of tables. Tables and/or locations not guaranteed after **September 1, 2024.**
- Registrations with special requests (e.g., same as last year, next to John Doe, etc.) must be received by **September 1** to be honored. Special requests will be honored, if possible, but cannot be guaranteed.
