**7:00 pm – November 4, 2024, by Zoom.**

Present: (Board) Marv Houg, John Catalani, Dale Stout, Tom Williams, Bob Rondinelli, Karl Stuekerjuergen, Sharon Sonnleitner, Ben Worrell, Tiffany Adrain (scribe). Apologies: Jim Preslicka

Meeting - Call to Order - Marv called the meeting to order at 7.19pm.

Secretary's Report – Tiffany circulated Minutes from September 2024. Bob motioned to accept Minutes; John seconded. Minutes were approved.

Treasurer's Report - Jim sent the report by email. Checking: \$15,334.36; savings: \$2,178.68; total: \$17,513.36. All EXPO 2024 bills have been paid except for the rental fees to LOESS for the display cases (Tom will write the check); plus a few EXPO digest packets that need address confirmation. Otherwise, the Expo packets have been mailed out (postage per piece was \$4.68). The latest expected delivery dates were Nov 5 to 6. John motioned to approve Treasurer's Report. Tom seconded. Report approved.

2024 Show Recap – Orr Building, Springfield, Illinois.

- Theme for this year: Carboniferous.
- Dates: October 18-20, 2024.
- Comments from dealers: Tom reported that dealers want to stay in Springfield and that the Spring dates are more favorable than the Fall dates (Fall is in competition with other kid's activities).
- Attendance and door prizes: Dan (via Marv) reported 112 registrations for door prizes, mostly Illinois. 75 fossil kits were given out. Marv gave a BIG thank you to Dan for handling prizes and registration and for contributing prizes. Also, thanks to Dan's family for running the prizes activities. Dale noted that attendance dwindled over lunch hour (no food at Orr Building). Opening times on Sunday should be 8am to 12pm because dealers are leaving early and visitors are disappointed.
- Silent and Live Auctions: Silent auction ok, live auction takings were down, Marv noted, likely due to poorer quality of items. Suggested holding live auction nearer to tables so dealers can bid.
- Advertising: Spent \$595 on Facebook advertising by Dan. Ben confirmed he had received ads on Facebook.
- MAPS Day Programs: Dale reported a couple of speaker cancellations. Attendance was low (around a dozen). Ben cited problems with low volume of announcements until speakers were added. Dale will bring speakers again next year.

- Friday night Keynote Speaker: Marv and Tom reported good reviews/response for keynote speaker. Marv gave out EXPO 2025 cards.
- Donation box: need better signage and information on what donations support.
- Displays: Bob congratulated Marv, Tom and Karl on the quality of the displays.

### EXPO 2025

- Dates: May 9-11, 2025
- Theme: Extinctions.
- Motel Show and room reservations: there should be a list of open rooms for vendors and a map of rooms at the front desk. Bob asked about special accommodation rate at Northfield. Marv explained that Dan organizes that for dealers. Ben reported 37 dealer rooms ranging from \$92 - \$99 plus tax. Eleven rooms were registered to show guests. Register early for the best deal.
- Website: Jim has updated the MAPS website with the new dates for EXPO 2025. The front and back of the new promo 2025 cards are available on the website and can be downloaded as a jpeg. Will add new flier when Sharon has it prepared and will be adding newer EXPO photos to various pages soon.

### Old Business

- Crinoid Project: Bob will continue with the project soon and discuss with Tiffany.
- Bank signatories: Still need to get Dale added.
- Badges: still needs to be done. Tom has another source for badges if necessary.

### New Business

- Increased Orr Building costs for 2025: building rent per day \$1,100 to \$1,550. MAPS Board members offered to make donations, but table rates will have to go up. New flat fee of \$50/table would cover cost of building rental and cleaning. Tom asked Marv to check with Tammy that building was cleaned satisfactorily.
- Relocation of EXPO:
  - Johnson Co Fairgrounds: Sharon provided information. 60 x 140 ft open plan (not sure of shape). \$2,500 for 3-day weekend. \$250 set up time. Includes tables and chairs but not cleaning. Determined to be too small.
  - Northfield Motel: also too small.
  - Big Bend Expo Center, East Moline: 100k sq ft. Marv trying to get in touch. Tom stressed dealers' response to East Moline NOT positive.
  - Chicago area: Tom and John assured everyone it would be too expensive.

EXPO 2025 – Orr Building, Springfield, Illinois.

- Dates: May 9-11, 2025
- Theme: Extinctions.
- Dealers: Tom anticipating at least 100 tables. Dan concerned about dwindling dealers. Tom responded that it's a balance with expected visitors/buyers, some dealers have many tables, and it will take a few years for dealers to adapt to change in dates. Dealers like Springfield, moving to Spring will be beneficial. Tom has a master list of dealers for emailing information. Marv suggested dealers could bring non-fossil material.
- Advertising: Door prize form provided 114 contacts for advertising, mostly in Illinois, some in Ohio. Can see from list which advertising methods were effective. Dan will organize a mass email two weeks before Expo. Facebook boost cost \$595, but Dan suggested that \$300-\$400 will be more cost effective. **Karl motioned to budget \$400 for Facebook ads for 2025. Tom seconded. Motion carried.** Dan paid for an ad in Rocks and Minerals. Marv thanked Dan. Tiffany will email fossil clubs and local museums. Tom will handle calendars.
- Signage around town: Dan will organize simple signs, "Fossil Show. Orr Building."
- Facebook: Flyer needs to be posted to our site plus many other sites – Jim/Sharon
- MAPS Day Speakers: Dale will ask around.
- Keynote Speaker for Extinctions: send suggestions to Tom. Dan will talk to people at Tucson show. Possibly split and flight costs with CVRMS for a talk?

Secretary's Report – Tiffany circulated Minutes from December 2024. Tom said he has master list of dealers for emailing. Dale motioned to approve the Minutes. John seconded. Minutes were approved.

Treasurer's Report – John circulated the Treasurer's Report. Checking: beginning \$15,112.90 plus \$160 deposited on Jan 6; minus payment to Dan Cooper (\$600); savings: \$2,178.68; total: \$16865.39. Tom reported one of the display cases was damaged (glass had to be replaced) – will send Jim invoice. Karl motioned to approve Treasurer's Report. Tom seconded. Report approved.

EXPO 2025– Orr Building, Springfield, Illinois.

- Orr Building rental: check for February, remainder due, plus cleaning.
- Dealers: Tom anticipating a flurry after Tucson.

Tom and Karl suggested allowing a percentage of non-fossil items per dealer, e.g. 30% of material or 1 out of 3 tables rented could be non-fossil, as long as earth science related. Bob recalled waiting in line to enter shows years ago. Karl stated fossil material getting harder to acquire. Marv compared the Cedar Valley Rocks and Minerals Society show in Cedar Rapids, IA, which brings in

5,000 people in 2 days. This would not happen if it was just fossils. Karl suggested a one-year trial, but Tom advised that it would take longer. Chris moved to include mineral and other natural history material in MAPS Expo sale content. Karl seconded. Motion approved. Sharon will modify flyer. Marv will develop a brief statement for Jim to email to MAPS members. Ratio will be 1/3 non-fossil to 2/3 fossils. Let Dan's dealers know in case they would like to buy tables.

Treasurer's Report – Jim circulated the Treasurer's Report. Paid \$623.54 for the second issue of the Digest and \$6.89 in bank fees; deposited \$240 in dues and \$2,360 for Expo. Checking: beginning \$16,656.11; savings: \$2,178.94; total: \$18,835.05.

- Orr Building rental: Marv estimates c.\$8k-9k Expo costs to be paid. Has a contract that needs to be paid by April 18. Jim will send check for \$3,255 to Illinois Department of Agriculture. Cost does not include cleaning (\$690) as Marv is waiting for confirmation from Elston Cleaning.

- Dealers: Tom reported c.75 tables sold so far. Anticipates 100 tables (need that to be financially viable). Five dealers (at least 30 tables) from last year not coming back due to conflicts, etc. Some hotel rooms may be available. Announced new policy for expanding sale item type. John sent Marv's letter about this to over 100 contacts. Marv is receiving positive feedback about expanding sales items. Needs list of motel dealers from Dan Cooper. Contact anyone you think might be interested.
- Door prizes: Can be minerals too.
- Displays: Tom asked Karl for leaf fossil of extinction survivors. Tom will display crinoids and Ice Age material, needs trilobites. John will create a nautiloid lineage.
- Advertising: Jim will put updated flyer on website. Dan is considering TikTok ad – will need to set up an account. Marv will discuss with Dan. Dan placed ad in Rocks and Minerals. Tom sent info to Rock & Gem Magazine community calendar. Tom will send flyer to local groups. Marv will talk to Kim about Facebook pushes. Sharon as emailed latest version of flyer to everyone. There are fewer shows to advertise at. Tiffany will email fossil clubs and museums.
